\* This information regarding the decorative rocks comes from our Jan. 9 2018 meeting. The following proposal was presented: If your ball comes to rest in the decorative rocks, and the rocks interfere with your stance or your intended swing, Rule 24b applies. You may drop your ball within one club length of the nearest point of relief, no closer to the hole, with no penalty. This motion was made by Kandy Moore and seconded by Betty Morris to adopt this ruling. Motion was passed.
